**1.**

A special meeting is currently scheduled for June 13, 2022, at 3:30 PM before the Shreveport City Council regarding the possible suspension of NGD Inc.'s Alcohol Beverage Permit as it relates to NGD Inc.'s business located at 2025 Marshall Street, Shreveport, LA 71101.

**2.**

The request for suspension has been made to the Shreveport City Council by Chief Wayne Smith of the Shreveport Police Department.

**3.**

Numerous Public Records requests were made of the Shreveport Police Department, the Shreveport City Attorney's Office and the Shreveport City Council on June 1, 2022.

**4.**

The deadline for response to these numerous requests is on or before 5 PM June 8, 2022.

**5.**

Even if the responses to the numerous Public Records requests can be provided by said deadline, the amount of information expected to be contained within the responses make it all but

impossible to review and allow Mr. Brooks time to adequately prepare his case for the evidentiary hearing before the Shreveport City Council regarding this matter.

Further, Wade Visconte, co-counsel for Gary Brooks and NGD, Inc., in this matter will be unavailable as his wife has a cardiology appointment scheduled for 2 PM on that same date.

7.


NGD Inc., shows to the Council that its business located at 2025 Marshall Street has been voluntarily closed since April 2, 2022.


