PURPOSE

To appropriate Choice Neighborhoods Planning (Action Activities) Grant funds awarded by the U. S. Department of Housing and Urban Development (HUD) for Allendale, Ledbetter Heights and the West Edge of Downtown Shreveport.

All**BACKGROUND INFORMATION**

The City of Shreveport was awarded \$1,000,000.00 by HUD to develop an action activity that addresses the physical neighborhood improvements of an area within the Choice Neighborhood boundaries. Shreveport's action activity is the construction of a Kitchen Incubator/Culinary Medicine Center. It will function as a business incubator, training center, and community space, all focused on culinary industries and health. The proposed facility will be a 5,000 square foot facility located at the corner of Milam and Christian Street in the Ledbetter Heights neighborhood on a 2.2 acre tract.

WHEREAS, the City Council finds it necessary to amend the 2017 budget for the Community Development Special Revenue Fund, to adjust appropriations, reflect current revenue estimates and for other purposes.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, in legal session convened, that Ordinance Number 105 of 2016, the 2017 budget for the Community Development Special Revenue Fund, is hereby amended as follows:

In Section 1. (Estimated Receipts):

<u>2016 and Prior Year Funds:</u>	
Establish HUD – Choice Neighborhood	\$1,000,000.00

In Section 2. (Appropriations):

<u>2016 and Prior Year Funds:</u>	
Establish HUD - Choice Neighborhood	\$1,000,000.00

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof shall be held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED that all ordinances or portions thereof in conflict herewith are hereby repealed.
