PURPOSE

BACKGROUND INFORMATION

Blood Center Properties Subdivision is located in the south part of Shreveport at the northwest corner of Linwood Avenue and Inner Loop Expressway intersection.

Mr. Robert Westerman, City Engineer, has recommended that the additional right of way dedication as shown on the plat be dedicated to the public for public use in the City of Shreveport.

The Metropolitan Planning Commission approved the plat on January 30, 2017.

BE IT RESOLVED by the City Council of the City of Shreveport, in due, legal, and regular session convened, that the dedication for Sugarleaf Trail right of way, in Section 35, (T17N-R14W), Caddo Parish, Louisiana, and as shown on the plats attached hereto and made a part hereof, be and the same is hereby accepted as dedicated to the public for public use in the City of Shreveport.

BE IT FURTHER RESOLVED that the original plat reflecting the dedication for Sugarleaf Trail right of way, be recorded in the official records of the Clerk of Court for Caddo Parish, Louisiana.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER RESOLVED that all ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.
