A RESOLUTION TO SUSPEND PROVISIONS OF CHAPTER 10 AND CHAPTER 106 OF THE CODE OF ORDINANCES RELATIVE TO THE SALE, DISPENSING AND CONSUMPTION OF ALCOHOLIC BEVERAGES AT RED RIVER BREWING COMPANY DURING A PRIVATE CRAWFISH BOIL HOSTED BY THE INDEPENDENCE BOWL FOUNDATION FOR ITS MEMBERS AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the Independence Bowl Foundation will host a private Crawfish Boil for its members at Red River Brewing Company Saturday, April 29, 2017, between the hours of 11:00 a.m. and 2:00 p.m.; and

WHEREAS, this private Crawfish Boil is being conducted at the Red River Brewing Company between the hours of 11:00 a.m. and 2:00 p.m. and during this time the Red River Brewing Company in not open to the general public; and

WHEREAS, the Red River Brewing Company desires to dispense, sell, and allow its patrons twenty-one (21) years of age and older, attending the private event, to purchase and consume alcoholic beverages on the deck and parking lot located at 1200 Marshall Street; and

WHEREAS, the adoption of this resolution would allow the dispensing, sale, purchase and consumption of alcoholic beverages on the deck and parking lot located at Red River Brewing for the Crawfish Boil; and

WHEREAS, the Red River Brewing Company desires to allow its patrons under the age of twenty-one (21) years old, attending the private event accompanied by an adult, to come and go inside the premises during this private Crawfish Boil; and

WHEREAS, subject to the requestor's compliance with local and State law requirements, the adoption of this resolution would allow the dispensing, sale and consumption of alcoholic beverages at these events.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened that the provisions of Chapter 10 and Chapter 106 of the Code of Ordinances are hereby suspended at Red River Brewing Company located at 1200 Marshall, Shreveport, Louisiana on Saturday, April 29, 2017, between the hours of 11:00 a.m. and 2:00 p.m. for a private Crawfish Boil, to the limited extent necessary to allow this event. All other provisions of said chapters of the Code of Ordinances shall remain in full force and effect. This suspension shall not apply to the sidewalk or the street unless the street has been closed by proper authority.

BE IT FURTHER RESOLVED that if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or application, and to this end, the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.
