PURPOSE
To amend the 2019 Riverfront Development Fund Budget, in accordance with State law and City Charter. To appropriate funds to the transition team, which encompasses experts and the community helps to inform and counsel best practices to develop the Mayoral strategic plan

The proposed strategic plan weighs the counsel of experts against input from citizens, resulting in a comprehensive report that spans every area of public life: economic development, technology, public safety, infrastructure, education, quality of life, entertainment, and community partners. Each section will outline the challenges that our community faces and make detailed policy recommendations designed to spur economic growth, enhance public safety, and improve living conditions for Shreveport residents.

AN ORDINANCE AMENDING THE 2019 RIVERFRONT DEVELOPMENT FUND BUDGET, APPROPRIATING THE FUNDS AUTHORIZED THEREIN, AND OTHERWISE PROVIDING WITH RESPECT THERETO:

WHEREAS, the City Council finds it necessary to amend the 2019 Riverfront Development Fund Budget.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, regular and legal session convened, that:

Ordinance Number 92 of 2018, the 2019 Riverfront Development Fund Budget, is hereby amended as follows:

1. Appropriations
Allocate from Contractual Services an amount not to exceed \$40,000 to fund the Mayoral Strategic Plan

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance 92 of 2018 as amended, shall remain unchanged and in full force and effect.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall become effective in accordance with the provisions of [Shreveport City Charter Section 4.23](#).
