WHEREAS, the RECIPIENT acknowledges that the "FIRE DISTRICT" remains responsible for obtaining any necessary maintenance and training in order to use the donated equipment;

WHEREAS, the RECIPIENT acknowledges that the "FIRE DISTRICT" holds all responsibility for proper operation of the donated equipment;

WHEREAS, the donation rendered is valued at two thousand dollars (\$2,000.00).

THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due regular and legal session convened, that the Mayor be and is hereby authorized to render the donation referenced herein and execute any necessary documents to complete the donation.

BE IT FURTHER RESOLVED that if any provision of this Resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or application of this Resolution which can be given affect without the invalid provisions, items or application and to this end the provisions of this Resolution are hereby declared severable.
