BACKGROUND INFORMATION

The City of Shreveport is required to submit a Consolidated Strategy Plan to the United States Department of Housing and Urban Development (HUD) which sets forth the planning and application aspects of the Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grants (ESG) program into a single submission. The 2019 Annual Action Plan contains the City's one-year plan of action for implementation of the 2019 Consolidated Strategy Plan Activities. The Consolidated Strategy Plan and the Annual Action Plan are a collaborative process whereby the community establishes a unified vision for community development actions. It integrates housing, economic, environmental, community, and human development in a comprehensive and coordinated fashion so that families and communities can work together and thrive.

BE IT FURTHER RESOLVED, that the Mayor is hereby authorized to execute and submit any and all documents necessary for the submission of 2019-2023 Consolidate Strategy Plan and the 2019 Annual Action Plan.
