Shreveport Development Corporation, acting through Anthony J. Janca, desires to donate to the City of Shreveport the water and sanitary sewer mains and related facilities to serve Marigny Woods Unit 2 in Twelve Oaks. The water and sanitary sewer facilities have been installed under the inspection of personnel from the Office of the City Engineer and have been reviewed by the Shreveport Fire Department.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Shreveport in due, legal and regular session convened, that Adrian Perkins, Mayor, be and is hereby authorized to execute on behalf of the City of Shreveport an Acceptance of Act of Donation with Shreveport Development Corporation represented by Anthony J. Janca, substantially in accordance with the terms and conditions contained in the draft of said agreement which was filed for public inspection with the original draft of the resolution in the office of the City Council on June 5, 2019.

**BE IT FURTHER RESOLVED** that if any provisions or items of this resolution or the application thereof are held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared severable.
