**PURPOSE**

This amendment transfers \$775,000 from Streets Special Revenue Fund to be placed in the 2019 Operating Budget for the Public Works Streets and Drainage Division.

This ordinance transfers funds from the Street Special Revenue Fund to the 2019 Operating Budget. The funds will be used by the Public Works Department for Contractual Services to continue much needed spot repairs to streets, drainage and sidewalks.

**WHEREAS**, the City Council provides for the amendment of any previously adopted budget, and

**WHEREAS**, the City Council finds it necessary to amend the 2019 budget for Streets Special Revenue Fund to adjust appropriations to apply towards Capital street project purposes.

**NOW THEREFOR BE IT ORDAINED** by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance No. 108 of 2018, the 2019 budget for the Streets Special Revenue Fund, is hereby amended as follows:

**In Section 2 (Appropriations)**

Increase Transfer to General by \$775,000

Decrease Improvement & Equipment by \$775,000

Adjust totals and subtotals accordingly.

**BE IT FURTHER ORDAINED** that the remainder of Ordinance 108 of 2018, as amended, shall remain in full force and effect.

**BE IT FURTHER ORDAINED** that if any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
