ORDINANCE NO. _____ OF 2019

AN ORDINANCE AMENDING THE 2019 GENERAL FUND BUDGET, APPROPRIATING THE FUNDS AUTHORIZED THEREIN AND OTHERWISE PROVIDING WITH RESPECT THERETO.

BY:

WHEREAS, the City Charter provides for the amendment of any previously adopted budget; and

WHEREAS, the City Council finds it necessary to amend the 2019 budget for General Fund to adjust appropriations to apply towards Street Project purposes.

NOW THEREFOR BE IT ORDAINED by the City Council of the City of Shreveport, in due, regular and legal session convened, that Ordinance No. 93 of 2018, the 2019 budget for the General Fund, is hereby amended as follows:

In Section 1 (Estimated Receipts)

Increase transfer from Street Special Revenue Fund by \$775,000

In Section 2 (Public Works)

Increase Contractual Serviced by \$775,000

Adjust total and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance 93 of 2018, as amended, shall remain in full force and effect.

BE IT FURTHER ORDAINED that is any provisions or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby

declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
