PURPOSE
 To amend Chapter 50, Article V, Smokefree Air Act.

BACKGROUND INFORMATION
 Ordinance 51 of 2020 was passed on June 9, 2020 with an effective date of August 8, 2020. This ordinance changes the effective date, for gaming facilities only, to August 1, 2021. In addition, this ordinance corrects the numbering of Sec. 50-214 and 50-215.

ORDINANCE NO. _____ OF 2020

AN ORDINANCE TO AMEND CHAPTER 50, ARTICLE V OF THE CITY OF SHREVEPORT, LOUISIANA CODE OF ORDINANCES REGARDING THE EFFECTIVE DATE OF THE SMOKEFREE AIR ACT, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana, in due, regular and legal session convened, that Chapter 50, Article V of the Code of Ordinances of the City of Shreveport, is hereby amended as follows:

Renumber the current **Sec. 50-214. Severability** as **Sec. 50-215. Severability**

Renumber the current **Sec. 50-215. Effective date** as **Sec. 50-216. Effective date**

BE IT FURTHER ORDAINED that Chapter 50, Article V, Section 50-216 of the Code of Ordinances of the City of Shreveport, is hereby amended to read as follows:

Sec. 50-216. Effective date

(a) This Article shall be effective August 8, 2020, except that the effective date for a Gambling facility shall be August 1, 2021.

BE IT FURTHER ORDAINED that the remainder of Chapter 50, Article V of the Code of Ordinances shall remain unchanged and in full force and effect.

BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given affect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all Ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall become effective in accordance with the provisions of [Shreveport City Charter Section 4.23](#).
