AN ORDINANCE AMENDING THE 2020 GENERAL FUND BUDGET, APPROPRIATING THE FUNDS AUTHORIZED THEREIN, AND OTHERWISE PROVIDING WITH RESPECT THERETO BY:

WHEREAS, the City Council finds it necessary to amend the 2020 General Fund Budget

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Shreveport, in legal session convened, that Ordinance 142 of 2019, the 2020 General Fund Budget, is hereby amended as follows:

In Section 1. (Estimated Receipts)

Increase 2020 Miscellaneous by \$43,200.00

In Section 2. (Appropriations)

Fire

Increase 2020 Personal Services by \$43,200.00

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 142 of 2019 as amended, shall remain unchanged and in full force and affect.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
