**COUNCIL DISTRICT****SPONSOR****PURPOSE**

To authorize the Mayor to execute a surface and subsurface servitude and easement agreement for the purpose to drill and produce multiple wellbores directionally and horizontally affecting a 113.8 acre tract of land owned by the City of Shreveport, and identified by Caddo Parish Tax Assessor's Geographic No. 161232-000-0027-00.

**BACKGROUND INFORMATION**

The City's Engineering and Environmental Services Department has received a request from Mr. James R. Madison, Jr., representing Aethon Energy Operating, LLC, (Aethon) for a surface and subsurface servitude agreement on property owned by the City of Shreveport, and commonly referred as the "sludge field" south of the City of Shreveport with an address of 11726 Harts Island Road, Shreveport, Louisiana. The total affected acreage is 6.457 acres and, Aethon is offering \$7,000 per acre for damages and surface and subsurface compensation with this agreement. Total consideration will be Forty-five Thousand One Hundred Ninety-nine Dollars (\$45,199.00). This agreement will allow Aethon to ingress and egress on the property to drill and produce multiple wellbores directionally and/or horizontally through the subsurface of the 6.457 acres. A copy of the surface and subsurface servitude and easement agreement is attached hereto, along with Exhibits "A" & "B", which identifies the exact affected area.

The City Engineer, or his designee, has reviewed the surface and subsurface servitude and easement agreement and other supporting documents and does hereby recommend the City Council approve the proposed agreement as it appears to comply with the Shreveport City Code and City departmental policies and regulations.

**RESOLUTION NO. \_\_\_\_\_ OF 2021**

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A SURFACE AND SUBSURFACE SERVITUDE EASEMENT AGREEMENT AFFECTING A 113.8 ACRE TRACT OF CITY OWNED PROPERTY WITH AETHON ENERGY OPERATING, LLC, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

**BY COUNCILMEMBER:**

**WHEREAS**, the City of Shreveport desires to enter into a Surface and Subsurface Servitude Easement Agreement for the purpose of locating production or transportation facilities in, over, or under city-owned property (excluding the City's public rights-of-way); and

**WHEREAS**, the City's Engineering and Environmental Services Department has received a request for a surface and subsurface servitude and easement which shall cover approximately 6.457 acres of a 113.8 acre tract of City-owned property; and

**WHEREAS**, total consideration to be received by the City under this proposed Agreement shall be Forty-Five Thousand One Hundred Ninety-Nine (\$45,199.00) Dollars; and

**WHEREAS**, the City Engineer, or his designee has reviewed the supporting documents associated therewith and does hereby recommend the City Council approve the proposed Surface and Subsurface Servitude Easement Agreement as it appears to comply with the City departmental policies and regulations.

**WHEREAS**, this Surface and Subsurface Servitude Easement Agreement shall be authorized by resolution of the City Council and executed by the Mayor.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Shreveport, Louisiana in due, regular and legal session convened, that:

The surface and subsurface servitude and easement agreement is hereby approved for the development of oil and gas on the City owned property at 11726 Harts Island Road, Shreveport, Louisiana, known as the “sludge field”. The Mayor is hereby authorized to execute the Surface and Subsurface Servitude and Easement Agreement, substantially in accordance with the draft attached hereto and as shown and described in EXHIBITS “A” & “B”, and also to include any other related and accompanying documents to carry out the intent of this Resolution, between the City of Shreveport, Louisiana (“GRANTOR”) and Aethon Energy Operating, LLC (GRANTEE), for the purpose of developing oil and gas on city-owned property.

**BE IT FURTHER RESOLVED** that an offer of Forty-Five Thousand One Hundred Ninety-Nine (\$45,199.00) for the grant of this surface and subsurface servitude and easement be accepted.

**BE IT FURTHER RESOLVED** that if any provision or item of this Resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Resolution which can be given effect without the invalid provisions, items or applications and to this end the provisions of this Resolution are hereby declared severable.

**BE IT FURTHER RESOLVED** that all Resolutions or parts thereof in conflict herewith are hereby repealed.
