**PURPOSE**

This amendment will reflect the additional revenue provided by the City of Shreveport as a part of the Neighborhood Investment Program Grant in order to fund activities as outlined in the program grant agreement.

**BACKGROUND INFORMATION**

The budget amendment is intended to increase Other Revenue Miscellaneous by \$25,000 and to increase Contractual Services by the same amount so funds can be expended to provide neighborhood engagement instruction, planning, training and technical assistance to neighborhood based organizations funded by the City of Shreveport, Department of Community Development as a part of a grant agreement. The grant agreement is administered by the Shreveport Department of Community Development.

**WHEREAS**, the City Council finds it necessary to amend the 2021 Metropolitan Planning Commission Special Revenue Fund budget,

**NOW, THEREFORE BE IT ORDAINED** by the City Council of the City of Shreveport, in legal session convened, that Ordinance 140 of 2020, the Metropolitan Planning Commission Special Revenue Fund, is hereby amended as follows:

In Section 1 (Estimated Receipts)

Establish Other Revenue Miscellaneous by \$25,000.00

In Section 2 (Appropriations)

Increase Contractual Services by \$25,000.00

Adjust totals and subtotals accordingly.

**BE IT FURTHER ORDAINED** that the remainder of Ordinance 140 of 2020, shall remain unchanged and in full force and effect except as amended herein.

**BE IT FURTHER ORDAINED** that any provision or item of this ordinance application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of the ordinance with can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** that all ordinances or parts thereof in conflict herewith are hereby repealed.
