WHEREAS, the City of Shreveport and the City of Alexandria desire to enter into a cooperative purchasing agreement under the terms of a contract the City of Shreveport entered into under the terms of IFB No. 21-005.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened that Adrian Perkins, Mayor, be and is hereby authorized to execute an agreement between the City of Shreveport and the City of Alexandria, substantially in accordance with the draft thereof filed in the Office of the Clerk of Council on September 28, 2021, and attached hereto as Exhibit A.
