PURPOSE

This ordinance amends Chapter 102, Article II of the Code of Ordinances.

BACKGROUND INFORMATION

This ordinance reduces the annual license fee for taxi, limousine, luxury vehicle and shuttle businesses from \$150.00 per vehicle to \$37.00 per vehicle for a period of one year beginning November 1, 2021 and ending October 31, 2022.

AN ORDINANCE TO AMEND CHAPTER 102, ARTICLE II, OF THE CITY OF SHREVEPORT, LOUISIANA, CODE OF ORDINANCES RELATIVE TO VEHICLE FOR HIRE LICENSES AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

BE IT ORDAINED by the City Council of the City of Shreveport, Louisiana in due, legal and regular session convened, that Chapter 102, Article II, Sec. 102-43 of the City of Shreveport, Louisiana Code of Ordinances is hereby amended to read as follows:

Sec. 102-43. Fees.

The fee for a vehicle for hire license issued by the city for taxi, limousine, luxury vehicle and shuttle businesses shall be \$150.00 per vehicle, per year. Except, a vehicle for hire license issued by the City for taxi, limousine, luxury vehicle, and shuttle businesses shall be \$37.00 per vehicle from November 1, 2021 through October 31, 2022. All fees shall be payable to the city through the Shreveport Police Department. All licenses shall expire 12 months from issue and must be renewed by the city in order to remain in force.

BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Ordinance which can be given affect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all Ordinances or parts thereof in conflict herewith are hereby repealed.

BE IT FURTHER ORDAINED that this Ordinance shall become effective in accordance with the provisions of [Shreveport City Charter Section 4.23](#).
