PURPOSE

This amendment establishes a new line item in the SporTran budget for SporTran ARP Transfers with an initial appropriation of \$250,000 for 2021 projects. This is a companion ordinance for the SporTran Capital Improvements budget amendment. The cost of this ordinance is listed at \$0.00. The cost of \$250,000 is reflected in the Capital Improvements budget amendment.

BACKGROUND INFORMATION

The 2021 winter storm event posed significant operational challenges for SporTran and highlighted areas of need to minimize service disruptions in the future. This project will fund the purchase of snow chains for a portion of the SporTran bus fleet and will fund 4-wheel drive SUVs to improve SporTran's ability to safely operate and provide emergency assistance during severe weather events.

AN ORDINANCE AMENDING THE 2021 BUDGET FUNDING CONTRACTUAL SERVICES PROVIDED TO SPORTRAN BY METRO MANAGEMENT ASSOCIATES, INC. AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, the City Council finds it necessary to amend the 2021 Budget Funding Contractual Services Provided to Sportran by Metro Management Associates, Inc.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Shreveport, in legal session convened, that Ordinance No. 148 of 2020, Budget Funding Contractual Services Provided to SporTran by Metro Management Associates, Inc., is hereby amended as follows:

Adjust totals and subtotals accordingly.

In Section 2. Appropriations,

General Government

Decrease Operating Reserve by \$250,000

Establish a Transfer to SporTran ARP line item with an appropriation by \$250,000.

Adjust totals and subtotals accordingly.

BE IT FURTHER ORDAINED that the remainder of Ordinance No. 148 of 2020, as amended, shall remain unchanged and in full force and effect.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and, to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED that all ordinances or parts thereof in conflict herewith are hereby repealed.
