AMENDING ORDINANCE

AN ORDINANCE AMENDING ORDINANCE NO. 108 OF 2015 ADOPTED ON NOVEMBER 24, 2015; AMENDING THE DESIGNATION OF THE PAYING AGENT; AMENDING THE TITLE OF THE ORDINANCE; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the governing authority (the "Governing Authority") of the City of Shreveport, State of Louisiana (the "City" or "Issuer"), passed Ordinance No. 108 of 2015 on or about November 24, 2015 (the "Bond Ordinance"); and

WHEREAS, it has come to the attention of the City that a necessity exists for changing the paying agent in the Bond Ordinance as well as the title of the Bond Ordinance; and

WHEREAS, it is now the desire of the Governing Authority to amend the Bond Ordinance with respect to the designation of the paying agent therein (the "Paying Agent") and the title thereof;

NOW, THEREFORE, BE IT ORDAINED by the Governing Authority, that:

ARTICLE I
Paying Agent Designation

Section 101. Definitions. The definition of "Paying Agent" in the Bond Ordinance shall be amended to read as follows:

"Paying Agent" with respect to the Bonds means Whitney Bank, a Mississippi banking corporation, Baton Rouge, Louisiana unless and until a successor Paying Agent shall have assumed such responsibilities.

Section 203. Notices. Section 411 of the Bond Ordinance, with respect to the Paying Agent, shall read as follows:

ARTICLE II
Title of the Bond Ordinance

Section 201. Title of the Bond Ordinance. The title of the Bond Ordinance shall be amended from "**THIRTY-SECOND SUPPLEMENTAL ORDINANCE**" to the following:

THIRTY-THIRD SUPPLEMENTAL ORDINANCE

ARTICLE III
Force and Effect

Section 301. Full Force and Effect. In all other respects the Bond Ordinance shall remain in full force and effect and unaltered hereby.
