**A RESOLUTION TO AMEND THE FEE SCHEDULE FOR THE EMERGENCY MEDICAL SERVICES DIVISION OF THE SHREVEPORT FIRE DEPARTMENT AND TO OTHERWISE PROVIDE WITH RESPECT THERETO**

WHEREAS, City Code Section 46-32(a), authorized the City Council to adopt a Fee Schedule for emergency ambulance and medical services by Resolution. It further authorizes any future amendments to the Fee Schedule to be adopted by Resolution; and

WHEREAS, the Fee Schedule will be kept on-file with the Shreveport Fire Department NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, in due, legal and regular session convened, that the Shreveport Fire Department fees be changed as follows:

1. The emergency transport "Loaded Mileage Fee" be increased from \$20.00 per mile to \$25.00 per mile; and,
2. The Base Rate fees for "Basic Life Support (BLS)" be increased from \$900.00 to \$1200.00; and,
3. The Base Rate fees for "Advanced Life Support (ALS)" be increased from \$1000.00 to \$1500.00; and,
4. The Base Rate fees for "Advanced Life Support II (ALS II)" be increased from \$1100.00 to \$2000.00; and
5. The Treat-No Transport Fee WITHOUT medication will be established at \$250.00, and
6. The Treat-No Transport Fee WITH medication will be established at \$500.00, and
7. The Specialty Care Transport Fee will be established at a base rate of \$2,500.00.

**A RESOLUTION DECLARING CERTAIN CITY OF SHREVEPORT, LOUISIANA, SUPPLIES, MATERIALS AND EQUIPMENT, SPECIFICALLY VEHICLES, TO BE SURPLUS AND TO AUTHORIZE THE PURCHASING AGENT, OR HER DESIGNEE, TO SELL AND DISPOSE OF SAID SURPLUS PROPERTY BY PUBLIC AUCTION AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.**

WHEREAS, the City of Shreveport ("City") is the owner of supplies, materials and equipment (i.e. movable property), specifically vehicles, shown in Exhibit "A" attached hereto and made part hereof; and

WHEREAS, Shreveport City Charter Section 10.04 (e) states, the Purchasing Agent shall have the authority to transfer, to or between departments and agencies of the City, or to sell supplies, materials and equipment determined to be surplus, obsolete or unused after consultation with the

head of the department concerned; and

WHEREAS, the Purchasing Agent, after consultation with the department heads, is recommending that the items shown on Exhibit "A" be declared surplus because they are obsolete and unusable for present and future City needs; and

WHEREAS, pursuant to Shreveport City Code Sec. 26-291(f), the sale of supplies, materials and equipment having an acquisition value of \$10,000.00 or more is prohibited unless such property is declared by Resolution to be surplus; and

WHEREAS, "[t]he sale of surplus public property shall be by competitive bids after public notice" pursuant to Shreveport City Code Sec. 26-292; and

WHEREAS, La. R.S. 49:125(A), authorizes the City to sell surplus movable property at public auction, in addition to the other methods provided by law for such sales and is also authorized to employ qualified licensed auctioneers to handle said sale; and

WHEREAS, in accordance with La. R.S. 49:125(B), no sale at public auction shall be at a price which is less than is required by law, and all such sales shall be advertised in the manner provided by law; and

WHEREAS, in accordance with La. R.S. 49:125 (C), the City shall reserve the right to reject any and all bids and remove said item(s) of movable property from sale; and

WHEREAS, in accordance with Shreveport City Code Sec. 26-52, all titles to automotive vehicles/equipment owned by the City shall be held in the custody of the superintendent of fleet services and the Purchasing Agent shall be authorized to sign all titles to automotive vehicles owned by the City when said automotive vehicles/equipment are declared as surplus and are subject to being sold; and

WHEREAS, the Purchasing Agent is recommending such action(s) be taken in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, legal and regular session convened that:

1. The City owned supplies, materials and equipment (i.e. movable property) shown in Exhibit "A" attached hereto and made part hereof and having an acquisition value of \$10,000.00 or more are hereby declared to be surplus property.
2. The Purchasing Agent, or her designee, is hereby authorized to sell and dispose of said surplus movable property in accordance with Shreveport City Code Sec. 26-292 by competitive bids after public notice and is also authorized to sell said property at public auction in accordance with La. R.S. 49:125.

WHEREAS, there are many capital improvements projects which are needed for the growth, prosperity and proper functioning of the city; and

WHEREAS, such projects can be funded through a general obligation bond issue if approved by the voters of the city in an election; and

WHEREAS, the City Council wishes to receive the input of a broad range of citizens as to the greatest needs and priorities for such funding.

**AMENDMENT NO. 1 TO ORDINANCE NO. 66 OF 2019:** By: Councilman Green  
An ordinance to amend various articles and sections in the City of Shreveport, Louisiana, Unified Development Code and to otherwise provide with respect thereto.

**AMEND THE ORDINANCE AS FOLLOWS:**

In Ordinance No. 66 of 2019, remove code text amendment number 14 and delete Exhibit D, and return said code text amendment to the Metropolitan Planning Commission for further review, and with instructions to specifically consider the following:

1. Delete the requirement that the food truck and trailer vendor is only permitted to operate in locations identified in the approved temporary use permit, and permit the vendor to operate on any properly zoned property, with written permission from the owner.
2. Require the vendor to agree to operate only on properly zoned property with the written approval of the property owner, as a condition of receiving the temporary use permit; and
3. Consider enforcing these and other reasonable rules and regulation with fines, and with the suspension or revocation of the temporary use permit.

**EXPLANATION OF AMENDMENT:**

This amendment requests the MPC to consider removing the requirement that a food truck vendor must provide the MPC with each location where the food truck will operate, and to substitute that requirement, with the requirement that the vendor agrees to abide by specific rules and regulation, with the understanding that the vendor can be fined or lose the temporary use permit if the agreement is not honored.
