A RESOLUTION TO APPROVE THE SUBMISSION OF AN APPLICATION TO RECOGNIZE THE HISTORIC WADDELL A-TRUSS BRIDGE OVER CROSS BAYOU AS A NATIONAL HISTORIC CIVIL ENGINEERING LANDMARK AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, the Louisiana Section of the American Society of Civil Engineers (ASCE) is submitting an application to recognize the A-Truss Bridge over Cross Bayou and the design engineer, John Alexander Low Waddell, as a National Historic Civil Engineering Landmark; and WHEREAS, the A-Truss Bridge over Cross Bayou is owned by the City of Shreveport and is listed on the National Register of Historic Places; and WHEREAS, the Historic A-Truss Bridge over Cross Bayou represents the work of John Alexander Low Waddell. Dr. Waddell was one of the preeminent bridge engineers in the United States at the turn of the 20th Century. Dr. Waddell received a patent for his A-Truss bridge in 1894. The A-Truss Bridge over Cross Bayou was erected across Cross Bayou by the KCS Railway Company in 1926. The A-Truss Bridge is one of only two surviving examples of this bridge type in the country. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened, that the A-Truss Bridge over Cross Bayou and the design engineer, John Alexander Low Waddell, be recognized for the significant contributions to the City of Shreveport and the railroad industry as a whole. BE IT FURTHER RESOLVED that the Shreveport City Council approves the submission of an application to recognize the Historic Waddell A-Truss Bridge over Cross Bayou as a National Historic Civil Engineering Landmark.

RESOLUTION NO. 83 OF 2020

A RESOLUTION REQUESTING THE DEPARTMENT OF JUSTICE AND/OR THE U.S.

ATTORNEY’S OFFICE TO OPEN A PATTERN OR PRACTICE INVESTIGATION OF THE SHREVEPORT POLICE DEPARTMENT AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, the City of Shreveport City Council has been recently faced with serious questions and concerns related to issues of accountability and lack of transparency for the actions of members of the Shreveport Police Department (“SPD”); and

WHEREAS, on April 5, 2020 Mr. Tommie McGlothen, Jr. died while in the custody of the Shreveport Police Department; and

WHEREAS, on April 19, 2020 Mr. Wavey Austin died in SPD custody; and

WHEREAS, the Caddo Parish District Attorney has stated publicly that there was a significant delay from the Shreveport Police Department in providing his office with their investigative files regarding the circumstances surrounding the deaths in police custody of Mr. Tommie McGlothen and Mr. Wavey Austin; and

WHEREAS, on June 29, 2020 eight (8) officers of the Shreveport Police Department were indicted by a grand jury on felony charges of malfeasance in office; and

WHEREAS, on or about July 10, 2019, two (2) officers of the Shreveport Police Department were respectively indicted for malfeasance in office and simple battery; and

WHEREAS, the citizens of the City of Shreveport have continued concerns surrounding the apparent lack of transparency and accountability related to the February 5, 2019 death of Mr. Anthony Childs; and

WHEREAS, while all of the aforementioned incidents require fact-specific investigations, the apparent lack of transparency and accountability by the members of the Shreveport Police Department raise serious concerns about whether their policies, procedures and practices are in conflict with lawful and effective policing in accordance with the constitutional rights guaranteed to all persons; and

WHEREAS, these incidents have further weakened an already strained relationship between the Shreveport Police Department and the citizens of the City of Shreveport; and

WHEREAS, The Violent Crime Control and Law Enforcement Act of 1994, 42 U.S.C. 14141 ("Section 14141"), authorizes the United States Attorney General to conduct investigations to eliminate a "pattern or practice of conduct by law enforcement officers ... that deprives persons of rights, privileges, or immunities secured or protected by the Constitution or laws of the United States."; and

WHEREAS, the Department of Justice’s Civil Rights Division is suited to conduct a wholly independent, nonpartisan review and investigation of the policies, practices and procedures of the Shreveport Police Department.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened that it hereby requests that the Department of Justice Civil Rights Division initiate a pattern or practice investigation into whether there are systematic violations of the Constitution or federal law by the Shreveport Police Department including but not limited to:

- (1) the SPD’s use of force,
- (2) the SPD'S handling of investigations of all allegations of officer misconduct, and
- (3) the SPD’s standards of training, equipment and supervision provided to its officers for the safe and effective performance of their duties.

BE IT FURTHER RESOLVED that if any provision of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications and to this end the provisions of this resolution are hereby declared severable.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.

Councilwoman Taylor: I'd like to also let you know that I am in support of this legislation as well but I want to make sure that I just have a few of my comments into the record. The fact that I sit here today as a member of this city council is testament to the work of the USDOJ and essentially, prior to their intervention, there were no Black elected officials in Caddo parish since the abrupt and violent ending of the Reconstruction. This drought of representation did not end until 50 years ago in 1970 and without USDOJ intervention, black women would have never elevated to beyond menial positions within the Shreveport Police Dept. Amazingly, it took them until 1976 to get Shreveport to hire its first Black firefighter. It wasn't until 1981 that they convinced Shreveport to lead all of Louisiana by hiring the first woman to be a professional firefighter. The USDOJ's various lawsuits, consent decrees and enforcement actions have served to push us closer and collectively towards a more "Union" by attempting continually to make real our American ideals of God given equality and unalienable rights. But unfortunately, the USDOJ as currently configured, has walked away from its historic role of trying to ensure "justice for all." That thereby bring some of my concerns and reference to them because of that tenure of Jeff Sessions, and I think that some of you can agree with me and now William Barr, such is no longer the case and the last act of Attorney General Sessions was to eviscerate the very mechanism that an investigation such as called for by this resolution will be used to make and force changes needed to correct the unconstitutional practices and patterns of an offending law enforcement agencies. I believe there in your resolution Councilwoman Fuller that we speak to DOJ or US Attorney's office, especially since this is about chief law enforcement entity, but I do want to keep in mind that I do have concerns under this present administration. If there is going to be an investigation under this term or that is probably going to be maybe years from now but I support this calling, willing to work in whatever capacity that I can to see that these things are brought forth.

A RESOLUTION TO RECOGNIZE THE CONTRIBUTIONS OF DR. CHARLEY M. LESTER JR. TO THE CITY OF SHREVEPORT AND TO AUTHORIZE THE MAYOR TO DEDICATE THE 4300 BLOCK OF HAYWOOD PLACE IN HIS HONOR, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, Dr. Charley M. Lester Jr., was born on February 28, 1934, in Scottsville Texas to Charley and Edna Lester; and

WHEREAS, Dr. Lester was a graduate of Pemberton High School, Wiley College in Marshall, Texas, and Meharry Medical College in Nashville, Tennessee, where he obtained his Doctor of Dental Surgery Degree in 1960; and

WHEREAS, Dr. Lester served his country as a member of the United States Air Force and was stationed at Croughton Air Force Base, in Bedfordshire, England, where he operated a dental clinic from 1962 to 1965; and

WHEREAS, in 1965 after completing his tour of duty in England, Dr. Lester returned to the Ark-La-Tex, and opened a dental practice in the Hollywood/Mooretown neighborhood in Shreveport; and

WHEREAS, also in 1965, Dr. Lester married Julie Boston Lester. They made their home in the Hollywood/Mooretown community where they raised their daughters, Kai and Charmel; and

WHEREAS, Dr. Lester took his civic responsibilities seriously. He served his community and the City of Shreveport in many ways, including the following: He was active in the Civil Rights Movement; in 1972, he was one of the first African Americans elected to the Caddo Parish Police Jury, now the

Caddo Parish Commission; he was a member of the Board of the Caddo Community Action Agency, and in 1979 he was an original appointee to the Board of Trustees of the Shreveport Home Mortgage Authority, where he served as president for many years; and

AN EMERGENCY ORDINANCE TO REQUIRE INDIVIDUALS TO WEAR PERSONAL PROTECTIVE MASKS OR FACE COVERINGS DURING THE COVID-19 PUBLIC HEALTH EMERGENCY WHILE IN PUBLIC, AND TO OTHERWISE PROVIDE WITH RESPECT

THERETO

BY COUNCILMAN: JERRY BOWMAN

WHEREAS, the City of Shreveport has the authority to preserve public peace, safety, morals, health and welfare; and

WHEREAS, pursuant to the Shreveport City Charter, Section 2.04(a) and (c) the City of Shreveport has the authority to “enact and enforce all necessary ordinances and regulations pertaining to public peace, safety, morals, health and welfare” and “take all actions necessary, requisite and proper to protect life and property in the event of an emergency”; and

WHEREAS, Governor John Bel Edwards declared a Public Health Emergency in response to COVID-19 on March 11, 2020, which was last extended on June 25, 2020; and

WHEREAS, Governor John Bel Edwards issued Proclamation 89 JBE 2020 on July 11, 2020 requiring masks to be worn in public; and

WHEREAS, Vice President Mike Pence and Surgeon General Jerome Adams have urged all Americans to wear masks to prevent the spread of COVID-19;

WHEREAS, COVID-19 has caused the deaths of more than 3,380 people in the State of Louisiana; and

WHEREAS, it is the desire of the City of Shreveport to preserve the public peace, safety, morals, health and welfare and take all actions necessary, requisite and proper to protect life during this COVID-19 Public Health Emergency; and

WHEREAS, the City of Shreveport has experienced alarming spikes in cases, hospitalizations, and deaths due to COVID-19; and

WHEREAS, information and data from medical professionals indicates that COVID-19 is more likely to be spread from individual to individual through close contact indoors and particularly through mass gatherings where people do not practice social distancing or wear personal protective masks or face coverings over the nose and mouth; and

WHEREAS, infected persons can transmit COVID-19 to others before showing any symptoms, and widespread and consistent use of personal protective masks or face coverings over the nose and mouth when in public is a critical and necessary measure to help slow the virus while allowing local businesses to continue to reopen and help the City of Shreveport economy reopen; and

WHEREAS, the spread of COVID-19 between individuals is greatly reduced through the wearing of personal protective masks or face coverings while indoors; and

WHEREAS, in accordance with Shreveport City Charter, Section 4.19, due to the COVID-19 Public Health Emergency, the City Council has determined it is necessary to enact this Emergency Ordinance requiring the use of personal protective masks or face coverings in order to preserve public peace, safety, morals, health and welfare and to protect life during this COVID-19 Public Health Emergency.

NOW, THEREFORE, BE IT ORDAINED that the City Council of the City of Shreveport, in accordance with Shreveport City Charter, Section 2.04(a) and (c), does hereby, in order to preserve public peace, safety, morals, health and welfare and to protect life during this COVID-19 Public Health Emergency, adopt the following provisions:

Section 1: In response to Proclamation 89 JBE 2020 issued by the Governor of Louisiana, John Bel Edwards, on July 11, 2020, within the City of Shreveport, personal protective masks or facial coverings must be worn and cover your nose and mouth in accordance with Proclamation 89 JBE 2020.

Section 2: In accordance with Proclamation 89 JBE 2020, certain individuals are exempt from wearing a mask or facial covering as outlined in the Proclamation.

Section 3: Proclamation 89 JBE 2020, Section 4 (A-C, E, and F) is hereby incorporated into this Emergency Ordinance in full.

Section 4: Businesses must require all customers, clients, and visitors to wear personal protective masks or face coverings in accordance with 89 JBE 2020.

Section 5: A violation of this Emergency Ordinance shall be a misdemeanor offense subject to a penalty of \$50.00 for a first offense and all subsequent offenses. No person shall be arrested or taken into

custody for a violation of this Emergency Ordinance.

Section 6: The provisions established herein shall become effective immediately and shall remain in place for the duration of Proclamation 89 JBE 2020.

BE IT FURTHER ORDAINED that this is an emergency ordinance in accordance with Shreveport City Charter, Section 4.19 in response to the COVID-19 Public Health Emergency for the immediate preservation of the public peace, health and safety.

Councilman Bowman: I did want to say, again, I appreciate everyone's consideration today. I know

it has been somewhat, some hard decision that had to be made, but that's what we are here for. I do also want to say also that Mayor Perkins did speak of his priority, what was to keep the citizens of Shreveport safe. I do want to keep that in mind and go on the record and say that safe from the pandemic and also safe as a city from other alignments that we have. Whether that's someone shooting, whether that's officers not doing what they are supposed to do and causing some kind of harm or death upon citizens. We need to make sure that we are doing all that we can, you know, I think Chief Raymond is still on, I have been to several different meetings in the past two weeks and at the end of each meeting, four meetings to be exact, and at the end of each meeting it was brought up, why not call for a vote of no confidence in Chief Ben Raymond. I had my part of putting Chief Raymond here hoping that he was in this seat, because I have great thoughts and beliefs that you would do what we asked of you to do and I am still hoping that is the case but, I am being pushed and pulled by many constituents that are asking for a vote of no confidence. I don't want to do that. I don't want to vote on that. I had to get that elephant out here because I know it's in the room, I know I heard Councilwoman Fuller earlier speak on, she said it was a culture. Am I correct Councilwoman Fuller?

Councilwoman Fuller: Yes.

Councilman Bowman: And I do believe that it is some kind of culture there, but when we go that route, we are still being hit with, well that starts at the head. Well, I understand that things happen beyond your control Chief, I get that. Somehow, some way the perception and I have been ranting on this for three years about perception, but we have to do something to get that perception out of the heads of our citizens. They are fearful and I too, can stand alone with them and be fearful on some instances with that and I will leave it there for today and whatever happens tomorrow is different and I do want to echo on the – Chief Raymond, if you had some comments that's fine, but I did want to say Councilman Boucher you spoke about we have to do something about the jobs, you know, things of that nature. I know that we have pushed and Mayor you ran on, you know, getting some jobs here and I know this pandemic has held us up on something but I hope there will be some kind of change and updates from you and your office and our economic development person. We need to get some kind of review or report from him from what he has been doing as far as getting some jobs here and if we need to turn the fire up under him and do something different and I'm going to leave it at that. Chief Raymond, did you have something?

Chief Raymond: No sir, councilman, I don't have any comments at this time, thank you.

Councilwoman Fuller asked Councilman Green to close the meeting by offering a word of prayer for Councilman Flurry, which he did.
