Suspect sought in bank robbery

Shreveport Police are seeking the identity of a man who robbed a local bank Friday afternoon.

Just before 3:00 p.m. on May 4, 2018, Shreveport Police patrol officers were called to the Regions Bank located in the 3700 block of Youree Drive, relative to robbery. As officers arrived at the scene, it was learned a black male wearing a plaid hat, dark shirt and tie entered the business and presented a note to the teller demanding money.

Fearing for her safety, the teller handed the suspect an undisclosed amount of money. After making off with the money, the suspect fled from the business on foot, traveling in an unknown direction. Police detectives have released video images of the suspect in hopes of identifying and apprehending the assailant.
