Multi-agency warrant round up yields arrests, narcotics

Multi-agency warrant round up yields arrests, narcotics

Shreveport Police officers teamed up with deputies from the Caddo Parish Sheriff's Office, Shreveport City Marshal's Office, agents with the Louisiana Department of Corrections Division of Probation and Parole and Troopers from Louisiana State Police for a warrants round-up late last week.

The collaborative initiative was an effort to round up misdemeanor and felony offenders, who collectively accounted for hundreds of outstanding warrants. Law enforcement officers split into teams consisting of personnel from each aforementioned agency.

Our media partners were invited to join us for the first phase of the operation, which started at 3:00 a.m. on Thursday, June 21st. The effort continued on Friday, June 22nd with authorities ultimately arresting 17 suspects and seizing approximately one and one-half pounds of marijuana as well as 14 suspected Ecstasy pills.
