Tabatha Taylor: Spoke in support of Ordinance No. 70 of 2019 and having a Unified Database for noncompliant citizens with mental health issues.

Councilman Boucher suggested using the Computer Aided Dispatch (CAD) system to help officers and first responders have more information before approaching a citizen.
