AMENDMENT NO. 1 TO RESOLUTION No. 87 of 2021 by Councilman Nickelson

AMEND THE RESOLUTION AS FOLLOWS: In the original proposed Exhibit A to Resolution No. 87 of 2021: 1. Add a new Subsection e. to Section VI. Performance Assurances to read as follows: e. Performance Bond. Contractor shall furnish to City a performance bond from a qualified corporate surety acceptable to the City in the amount of the total compensation indicated in this Agreement, and in a form approved by the City. No payment shall be due or made to Contractor until the performance bond has been received and approved by City.

EXPLANATION OF AMENDMENT: This amendment adds a clause to the Contract requiring a performance bond be provided by the Contractor

Councilman Green: Mr. Chair, just state for the record that this is not a ten-million-dollar contract, and I will repeat it again, this is not a ten-million-dollar contract. I will refer to the city attorney so that you can put on the record what amount that we are facing in this particular contract. Misinformation has been put out about this and I don't think that it is right that we would just state misinformation, that's wrong. So, would you give the amount of money that we are talking about.

City Attorney Lattier: We are talking about one point nine million dollars per year and obviously if she fulfills the five-year potential term of the contract that would amount to ten-million-dollar approximately. However, again, if the City of Shreveport is not satisfied with her performance that's after six months, it would only be on the hook to pay her for that amount for six months. If the city is satisfied with her performance for a whole year, then they would be on the hook for one point nine million dollars. But the city is not on the hook for ten-million-dollars. It's really just on the hook based upon her performance every month and she has to have specifics that she have to provide to the city with regard to what her requirements are and how she has completed those requirements. And again, if the city is not satisfied with her performance, they can terminate her contract at any time without cause and that's it, at any time, one month, two months, three months, it would be over.

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT BETWEEN THE CITY OF SHREVEPORT, LOUISIANA AND C. EDWARDS CONCEPTS, LLC. TO PROVIDE CURBSIDE RECYCLING WITHIN THE LIMITS OF SHREVEPORT AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

WHEREAS, in an effort to maintain a recycling option at no additional cost to the citizens, the City issued Request for Proposals (RFP) #20-828 for the purpose of identifying and selecting a new service provider for recycling services; and

WHEREAS, it has been determined by the RFP selection committee that C. Edwards Concepts, LLC of Shreveport is the most feasible, viable and effective option; and

WHEREAS, C. Edwards Concepts, LLC of Shreveport sets forth in its response that it can better serve the citizens of Shreveport by providing semi-monthly curbside collections; and

WHEREAS, the Contract shall be drawn substantially in accordance with the terms outlined in RFP #20-828 and is attached hereto and made part hereof.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, legal, and regular session convened, that:

Mayor Adrian Perkins be and is hereby authorized to execute, for and on behalf of the City of Shreveport, a Contract between the City of Shreveport and C. A RESOLUTION AUTHORIZING THE CITY OF SHREVEPORT, LOUISIANA, PURCHASING AGENT TO REJECT ALL PROPOSALS RECEIVED FOR THE AIRPORT CONCESSION PROGRAM PROPOSAL RFP #21-800 AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, on June 9, 2021, two (2) proposals were received as a result of solicitation for Airport Concession Program (RFP-21-800); and

WHEREAS, there has been a significant downturn in the airport industry and the resurgence of COVID, the concession industry has been negatively impacted; and

WHEREAS, pursuant to Shreveport City Charter Sec. 10.07, the Purchasing Agent may reject any and all proposals and readvertise for proposals with the approval of the City Council; and

WHEREAS, pursuant to Shreveport City Code Sec. 26-269 the City has adopted, by reference, portions of the Louisiana Procurement Code (La. R.S. 39:1551 and 39:1755); and

WHEREAS, La. R.S. 39:1605, authorizes the City to reject any and all proposals for the “best interest”; and

WHEREAS, the “best interest” under these facts and circumstances is authorized in La. R.S. 39:1605, whereby given the downturn in passengers in the airport industry last year and the resurgence of COVID in the last few months, the concession industry has been negatively impacted financially. We anticipate that the passenger numbers will increase next year which will equate to more business for the concession operator. and

WHEREAS, it has been determined by the City Council and Purchasing Agent, and/or his/her designee, that such action is being taken in the best interests of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, legal and regular session convened that:

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A PIPELINE(S) RIGHT-OF-WAY AND EASEMENT AGREEMENT FOR THE CONSTRUCTION OF AN OIL AND GAS PIPELINE WITH HAYNESVILLE GATHERING, LP, AN AFFILIATE OF AETHON ENERGY OPERATING, LLC, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO.

WHEREAS, Shreveport City Code Sec. 78-122 authorizes facility servitudes for the purpose of locating or constructing a facility across, in, over, or under city-owned property (excluding the City’s public rights-of-way); and

WHEREAS, an applicant for a facility servitude shall make application to the City Department of Engineering and Environmental Services and pay the applicable application processing fees and/or facility servitude annual fees in accordance with Shreveport City Code Sec. 26-109; and

WHEREAS, the City’s Engineering and Environmental Services Department has received a request for a facility servitude in accordance with Shreveport City Code Sec. 78-122; and

WHEREAS, the City Engineer, or his designee, has reviewed the submitted application and other supporting documents and does hereby recommend the City Council approve the proposed facility servitude as it appears to comply with the Shreveport City Code and City departmental policies and regulations; and

WHEREAS, pursuant to Shreveport City Code Sec. 78-122 a facility servitude shall be authorized by resolution of the City Council and executed by the Mayor.

The pipeline and right-of-way easement agreement is hereby approved for the construction of a new oil and gas pipeline on the City owned property at 11726 Harts Island Road, Shreveport, Louisiana, known as the “sludge field”. The Mayor is hereby authorized to execute the Pipeline(s) Right of Way and Easement Agreement, substantially in accordance with the draft attached hereto and as shown and described in EXHIBIT “A”, and also to include any other related and accompanying documents to carry out the intent of this Resolution, between the City of Shreveport, Louisiana (“GRANTOR”) and Haynesville Gathering, LP (GRANTEE), for the purpose of laying an oil and gas pipeline on city-owned property.

RESOLUTION NO. 111 OF 2021

A RESOLUTION FOR THE CERTIFICATION OF COMPLIANCE WITH THE STATE OF LOUISIANA OFF-SYSTEM BRIDGE REPLACEMENT PROGRAM, AND OTHERWISE PROVIDING WITH RESPECT THERETO

WHEREAS, the Code of Federal Regulations, as enacted by the United States Congress, mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity, and posted in accordance the National Bridge Inspection Standards and that an inventory of these bridges shall be maintained by each State; and

WHEREAS, the responsibility to inspect, rate and load post those bridges under the authority of the City of Shreveport in accordance with those standards is delegated by the Louisiana Department of Transportation and Development to the City of Shreveport.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, in due, regular, and legal session convened that the City does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period of 1 October 2021 through 30 September 2022:

1. The City will perform all interim inspections on all City owned or maintained bridges in accordance with the National Bridge Inspection Standards.
2. All bridges owned or maintained by the City will be structurally analyzed and rated by the City as to safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LADOTD for all bridges where the maximum legal load under Louisiana law exceeds the load permitted under the operating rating as determined above will be critically reviewed by the City. Load Posting information will be updated by the City to reflect all structural changes, any obsolete structural ratings or any missing structural ratings.

3. All City owned or maintained bridges which require load posting or closing shall be load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge shall be critically reviewed by the City Engineer prior to load posting.

4. All Bridges owned or maintained by the City are listed separately in the format specified by the DOTD. Correction to data supplied to the City by the LADOTD are noted.

BE IT FURTHER RESOLVED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this ordinance are hereby declared severable.
