
Dear Mr. Moore

Corey Moore was convicted in Gregg County, Texas, of Identity Theft, Illegal Carrying of a Weapon, Possession of Methamphetamines, and Simple Burglary of an Inhabited Dwelling on 10/09/2019. He was placed on 10 years community supervision. His probation was transferred to Louisiana and he has been under the supervision of the Louisiana DPSC Probation & Parole since 12/16/2019. During that time, he has successfully completed the Substance Use Disorder (SUD) Program through the VA in Shreveport. He has worked with the Compensated Work Therapy (CWT) Program at the VA. He has been successful in the Veterans Treatment Court Program. He has been a group leader and peer counselor with the Veterans Treatment Program. He has been working on his college education for social work online. Mr. Moore is a veteran of the United States Marine Corps. His concerted efforts to address his PTSD and subsequent addiction issues after his tours of duty have been consistent and longstanding. As his supervising officer, I have no opposition to him obtaining an ABO card in order to obtain and maintain employment to further his ReEntry efforts.
