**RESOLUTION NO. 113 OF 2021**

**A RESOLUTION IN SUPPORT OF THE CITY OF SHREVEPORT'S GUARANTEED INCOME PROGRAM, AUTHORIZING THE EXECUTION OF A MEMORANDUM OF UNDERSTANDING AND TO OTHERWISE PROVIDE WITH RESPECT THERETO**

WHEREAS, prior to the COVID-19 pandemic, nearly 45 million Americans, or 12% of the U.S. Population were living in poverty, including about 7 million employed people who did not have resources to cover even the most necessities despite their employment.

WHEREAS, many residents of the City of Shreveport struggled to support themselves and their families, and the economic shock of the pandemic has left them more vulnerable than ever.

WHEREAS, 46% of American households have experienced serious financial trouble during the pandemic, including running out of savings, trouble affording food, paying utility bills, and paying their rent or mortgage; and

WHEREAS, the U.S. Congress passed Coronavirus Aid, Relief, and Economic Security (CARES) Act at the end of March, which included a package of relief and stimulus programs including \$500 billion for large corporations and one-time \$1,200 Economic Impact Payment (EIP) checks to individuals; and

WHEREAS, in December of 2020, the U.S. Congress passed the second pandemic relief package, which included a \$600 EIP check to most Americans; and

WHEREAS, in March of 2021, President Biden signed the American Rescue Plan, which included a \$1,400 EIP check for most Americans and \$1,400 for each of their qualifying dependents; and

WHEREAS, the American Rescue Plan increased the child tax credit to \$3,600 for kids under age 6, and to \$3,000 for children 17 and under, and will be made through direct payments in 2021; and

WHEREAS, prior to the COVID-19 pandemic, nearly 45 million Americans, or 12% of the U.S. population, were living in poverty, including about 7 million employed people who did not have resources to cover even the most basic necessities, despite working; and

WHEREAS, nearly 40% of Americans could not afford a single \$400 emergency prior to the pandemic, and rising income inequality is compounded by an ever-growing wealth divide; and

WHEREAS, technology and automation are forecasted to further exacerbate the economic insecurities of working-class Americans, potentially eliminating as much as 25% of the workforce; and

WHEREAS, providing an income floor through which no American family could fall will benefit individuals and communities both now and in the future; and therefore the City of Shreveport should initiate a polite Guaranteed Income Program that offers a small group of low income single-parent families at least \$600 dollars a month for a year; and

WHEREAS, a guaranteed income would empower recipients to address their most urgent day to day needs and provide a cushion for unpredictable expenses; and

WHEREAS, these payments would be generated from money received from the Mayors for Guaranteed Income Fund, as well as other public, philanthropic and private funds.

WHEREAS, previous and ongoing experiments of guaranteed income programs have included some of the following results for participants: better educational outcomes, substantive improvements in physical and mental health, significant reduction of predatory debt, and greater confidence in having basic necessities met, with no appreciable impacts on the labor market.

NOW THEREFORE BE IT RESOLVED, that the Mayor and City Council supports a pilot program through the Mayors for Guaranteed Income coalition to provide direct cash payments for a year to qualifying recipients in accordance with the Work Plan annexed hereto as Exhibit A, or a Work Plan substantially similar in form and substance; and

BE IT FURTHER RESOLVED, that the Shreveport City Council urges President Biden, Speaker Pelosi and Leader Schumer to develop an ongoing federal guaranteed income that provides an income floor for all Americans.

BE IT FURTHER RESOLVED by the City Council of the City of Shreveport, in due, legal and regular session convened, that the Mayor of the City of Shreveport, or his/her designee, shall be and is hereby authorized to do any and all things and to sign any and all documents, in a form acceptable to the City Attorney, or his/her designee, necessary to effectuate the purposes set forth herein. Such documents shall include the Memorandum of Understanding annexed hereto as Exhibit B or a document substantially similar in form and substance.

BE IT FURTHER RESOLVED that if any provision or item of this Resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this Resolution which can be given effect without the invalid provisions, items or applications and to this end the provisions of this Resolution are hereby declared severable.

BE IT FURTHER RESOLVED that this Resolution shall become effective in accordance with the provisions of Shreveport City Charter Section 4.23.

BE IT FURTHER RESOLVED that all resolutions, ordinances or parts thereof in conflict herewith are hereby repealed.

**RESOLUTION NO. 115 OF 2021**

**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH JPMORGAN CHASE BANK, NA FOR THE FINANCING OF VEHICLES AND EQUIPMENT AND OTHERWISE PROVIDING WITH RESPECT THERETO.**

WHEREAS, the City of Shreveport, sometimes referred to herein as "Lessee" is a political subdivision of the State of Louisiana (the "State") and is duly organized and existing pursuant to the constitution and laws of the State.

WHEREAS, pursuant to applicable law, the governing body of the Lessee ("Governing Body") is authorized to acquire and dispose of real and personal property, including, without limitation, rights and interests in property, leases and easements necessary to the functions or operations of the Lessee.

WHEREAS, the Governing Body hereby finds and determines that the execution of one or more new lease-purchase agreements or Schedules to an existing Master Lease-Purchase Agreement ("Equipment Leases") in the principal amount not exceeding \$1,500,000 for the purpose of acquiring the property generally described below ("Property") and to be described more specifically in the Equipment Leases is appropriate and necessary to the functions and operations of the Lessee:

Brief description of property:

Vehicles and equipment for Water and Sewer Enterprise Fund

WHEREAS, JPMorgan Chase Bank, N.A., ("Lessor") is expected to act as the Lessor under the Equipment Leases.

WHEREAS, the Lessee has paid or will pay certain capital expenditures in connection with the Property prior to its receipt of proceeds of the Equipment Leases ("Lease Purchase Proceeds") for such expenditures and such expenditures have not exceeded or are not expected to exceed the Principal Amount.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport, Louisiana, in due, regular and legal session convened, that:

Section 1. Adrian D. Perkins, Mayor is hereby authorized to execute and deliver one or more Equipment Leases in a form approved by the City Attorney. The Mayor is further authorized to execute and deliver such other documents relating to the Equipment Lease (including, but not limited to, escrow agreements) as he deems necessary and appropriate. All other related contracts and agreements necessary and incidental to the Equipment Leases are hereby authorized.

Section 2. By a written instrument signed by the Mayor, the Mayor may designate specifically identified officers or employees of the City to execute and deliver agreements and documents relating to the Equipment Leases on behalf of the City.

Section 3. The aggregate original principal amount of the Equipment Leases shall not exceed the Principal Amount and shall bear interest as set forth in the Equipment Leases and the Equipment Leases shall contain such options to purchase by the Lessee as set forth therein.

Section 4. The Lessee's obligations under the Equipment Leases shall be subject to annual appropriation or renewal by the Governing Body as set forth in each Equipment Lease and the

Lessee's obligations under the Equipment Leases shall not constitute a general obligation of the Lessee or indebtedness under the Constitution or laws of the State.

Section 5. The Governing Body of Lessee anticipates that the Lessee may pay certain capital expenditures in connection with the Property prior to the receipt of the Lease Purchase Proceeds for the Property. The Governing Body of Lessee hereby declares the Lessee's official intent to use the Lease Purchase Proceeds to reimburse itself for Property expenditures. This section of the Resolution is adopted by the Governing Body of Lessee for the purpose of establishing compliance with the requirements of Section 1.150-2 of Treasury Regulations. This section of the Resolution does not bind the Lessee to make any expenditure, incur any indebtedness, or proceed with the purchase of the Property.

BE IT FURTHER RESOLVED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this ordinance which can be given effect without the invalid provisions, items or applications; and to this end, the provisions of this ordinance are hereby declared severable.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict herewith are hereby repealed.

WHEREAS, the Agreement was extended by the authority of the City's Resolution 159 of 2016 for a Subsequent Renewal Term of five (5) years effective October 1, 2016; and

WHEREAS, the City and MMA desire to continue the Agreement for a Subsequent Renewal Term of five (5) years, covering the period October 1, 2021 through September 30, 2026; and

WHEREAS, all other terms and conditions of the Agreement shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Shreveport in due, legal and regular session convened that Adrian Perkins, Mayor, is hereby authorized to execute Amendment No. 5 to the Management Agreement (the "Agreement") dated June 30, 2006, as

amended, substantially in the form filed in the office of the Clerk of Council on September 14, 2021.

WHEREAS, Governor John Bel Edwards declared a Public Health Emergency in response to COVID-19 on March 11, 2020; and

WHEREAS, the City Council, in order to limit public gatherings to only those necessary to carry on the business of the City, combined the administrative conference and regular meeting of the City Council; and

WHEREAS, the City Council now finds it necessary to return to having a separate administrative conference and regular meeting.

BE IT FURTHER ORDAINED that if any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications and to this end the provisions of this ordinance are hereby declared severable.
