**OPERATION MO**

On March 1, and March 2, 2022, the Shreveport Police Department's VCAT and Warrants Unit partnered with Caddo Parish Juvenile Services and the Louisiana Office of Juvenile Justice to execute "Operation MO". The collaborative effort was devised to capture juveniles who had outstanding Orders to Take into Custody (OTTIC) and juvenile probation warrants for violent offenses or firearms-related offenses. The mission is to ultimately disrupt the flow of juvenile criminal activities. Many of the juvenile offenders are active gang members.

All offenders were booked into Caddo Juvenile Detention Center or the Shreveport City Jail.
