SPD Seeking Wanted Suspects in Violent Domestic Incidents

The Shreveport Police Department is asking for the public's help in locating three individuals wanted in connection with violent domestic abuse cases. Each of these men is wanted for offenses involving violence and threats of violence against their partners and children.

Suspect 1: Lawron Johnson

Date/Time of Incident: March 12, 2025, at approximately 3:00 p.m.

Location: 4920 Ralph Place

Charges:

- Domestic Abuse Battery Upon a Pregnant Victim
- Domestic Abuse Battery Strangulation
- Domestic Abuse Battery Child Endangerment Law (3 counts)
- Domestic Abuse Aggravated Assault
- Possession of a Firearm or Carrying a Concealed Weapon by a Person Convicted of Certain Felonies
- Cruelty to Juveniles (2 counts)

The victim reported that during a verbal argument, Johnson placed both hands around her neck, making it difficult for her to breathe. She fell to the floor, where he continued to strangle her. The victim, who was four months pregnant, was able to kick him in the groin to break free. Johnson then armed himself with a firearm and threatened to kill everyone in the home. The couple's three children were present and witnessed the attack. Johnson also used a belt to strike the two oldest children multiple times.

Suspect 2: Michael Wilson

Date/Time of Incident: February 12, 2025, at approximately 1:00 a.m.

Location: 2922 Lillian Street

Charges:

- Domestic Abuse Battery Strangulation
- Domestic Abuse Battery Child Endangerment Law
- Domestic Abuse Aggravated Assault

The victim stated that her ex-boyfriend, Michael Wilson, grabbed her by the neck multiple times, impeding her airway during a heated argument. Her two-year-old daughter was present. Officers observed visible bruising on the victim's neck. Wilson also allegedly pointed a firearm at the victim, threatening to kill her if she did not tell him the truth during an argument about her cell phone.

Suspect 3: Christopher Lee Dieter Jr.

Date/Time of Incident: February 18, 2025, at approximately 12:52 p.m.

Location: 5725 Financial Plaza

Charges:

- Domestic Abuse Battery with Child Endangerment (3 counts)

The victim reported that her boyfriend, Christopher Dieter, used force against her without consent in the presence of their three young children (all under the age of 13). The victim was observed with visible injuries.
