14-Year-Old Wanted in Attempted Murder

The Shreveport Police Department is actively searching for a juvenile suspect following a violent shooting incident that occurred at the SporTran Hub. (Home of future SPD Substation)

On December 17, 2025, at approximately 1:57 p.m., Shreveport Police Uniformed Patrol Officers were dispatched to the SporTran Hub on St. Vincent Avenue in reference to a shots-fired call. Upon arrival, officers contacted the victim, who provided the following account.

The victim stated he was walking toward the bus hub when he was approached from behind by an unknown Black male who began yelling aggressively at him. The victim advised he did not know the individual and could not determine why the suspect was attempting to get his attention. Fearing for his safety, the victim ran inside the bus hub and entered a restroom, where he locked himself inside.

The suspect followed and attempted to force entry into the restroom but was unsuccessful. After several failed attempts, the suspect briefly left the area. Moments later, the suspect returned armed with a firearm. The suspect again attempted to enter the restroom. When entry was unsuccessful, the suspect verbally counted down and then fired multiple rounds into the restroom door while the victim was inside.

Fortunately, the victim was not struck.

On January 7, 2026, detectives with the Shreveport Police Department Investigations Division executed a search warrant at a residence connected to the investigation. During the warrant execution, the juvenile suspect was identified as Da'Michael Johnson (DOB: 07/03/2011), as the individual depicted in the footage and as the shooter in this incident.

At the time of the search warrant execution, the suspect was not at the residence. The grandmother advised detectives that the juvenile had not been home for approximately 24 hours.

On January 8, 2026, an **Order To Take Into Custody** (OTTIC) was signed by a judge for the 14-year-old juvenile in connection with the following charges:

- Attempted Second Degree Homicide
- Illegal Possession of a Firearm by a Juvenile
- Illegal Use of a Firearm

The Shreveport Police Department does not typically release information regarding juvenile suspects. However, due to the severity of this offense, the clear risk to public safety, and the fact that this incident involved an attempted murder in a public transportation facility, we are asking for the public's assistance in locating this individual as quickly as possible.

Anyone with information regarding the whereabouts of Da'Michael Johnson is urged to contact the Shreveport Police Department immediately. Tips can also be provided anonymously through Crime Stoppers.

This investigation remains ongoing.
