## **Mayor Tyler releases names of applicants for Police Chief**

The applications for Chief of the Shreveport Police Department were approved today in a special meeting by the Shreveport Civil Service Board. The names were then delivered to Mayor Ollie Tyler's office for public release.

There were 19 applicants who qualified to take the Civil Service Examination for Police Chief. The deadline for applications was Friday, Aug. 19, 2016. Each applicant must pass the examination to be considered as a candidate for the position. The exam will be given on Sept. 21, 2016.

Last month, Mayor Tyler appointed Alan Crump as Interim Chief to replace Chief Willie Shaw who retired July 31. Crump was appointed for 90 days to lead the department during the search process.

“This appointment is critical in ensuring the safety and well-being of our citizens and visitors, so I will take my time and make sure I select the right person for the job,” said Mayor Tyler. “This person needs to have strong integrity, loyalty and commitment to service. I am also seeking someone with a servant's heart to ensure the safety of our community as well as the fiscal acumen to operate an effective and efficient department.”
